Qualifiers 17 – 32 to compete in B Main with
First 4 placegetters to run rear of A Main.
Minimum 1 Lap per car plus 2 Laps to a
Maximum of 15 Laps

A MAIN

To be run over 20 laps
Top 16 qualifiers plus 1st, 2nd 3rd & 4th from B Main
Top pointscorer from heats starts
from position 1, 2nd highest point
scorer from position 2 and so on.

Trophies for 1st, 2nd & 3rd placegetters in A Main.

All A Main Drivers will receive a Medallion for
qualification to the A Main. All participants in the State Title
event will receive a participation medallion.

The Driver of the winning car will receive a Shirt
in recognition of their success.

TOWMONEY Tow money for interstate drivers to be negotiated.

NOTE: Drivers must pass scrutineering, to be eligible for tow money.

NOTE: Mandatory use of Transponders & One Way communicators will be in force for this
title. If you do not have your own transponder they may be hired from the QSCA Inc on race
day. All competitors **MUST** have their own radio receiver.

SCRUTINEERING:

Will be held at the racetrack, in the designated area.

Scrutineering will be conducted between **11.30 am and 1.30pm on Saturday 1st December 2007.** NOTE: **ALL CARS** must be available for inspection between the above times. Cars will not be accepted after 1.30pm, unless prior arrangement has been made with the State Tech Rep ASCF Bill Peall 0407 791 449 or State Secretary Terese Lange 0419 733 299. Late arrival will incur a penalty.

DRIVERS BRIEFING: **3.15pm** In the designated area in the pits.

LOG BOOK & LICENCES: Are to be handed to the scrutineer at scrutineering and obtained after the completion of the nights racing.

PRACTICE: NIL – All cars will be required to participate in Grand Parade for a transponder check.

RACING FROM: **4.00pm** unless otherwise notified

PROMOTION: ***Each driver is requested to supply a current photo of himself/herself and car for promotional purposes.***

GRID DRAWS: To be carried out by QSCA Inc, at close of scrutineering,. Your roof number allocation will be posted to you and after the Title your towmoney will be sent direct to you.

Driver to provide own roof numbers as per allocation.

1. Driver must hold a current ASCF Inc/NASR Licence.
2. Car must carry a current ASCF Inc decal and log book and be a currently registered ASCF Junior Sedan.
3. Late nominations will be accepted up to close of scrutineering. All nominations received after closing date will be required to pay late Nomination fee.
4. Nominations received by fax must have the original and cheque forwarded immediately, if not to hand within 7 days from close of nominations, will be required to pay the late nomination fee
5. Scratchings must be notified to State Secretary, (0419 733 299) prior to meeting. Failure to do so may incur a penalty.
6. Please note that all, tow or appearance money is stated in gross amounts. Where applicable 1/11th becomes the GST proportion liable. If required, you will undertake to supply to the QSCA Inc a compliant Tax Invoice for the payment of any monies. If no compliant Tax Invoice is forthcoming 48.5% will be deducted and forwarded to the ATO.
