All heats will be maximum 8 laps
Maximum of 12 cars per heat
Points - 36,28,23,17,13,10,8,6,5,4,3,2 and
1 to all other finishers

B MAIN

Qualifiers 17 – 32 to compete in B Main with
First 4 placegetters to run rear of A Main.
Minimum 1 Lap per car plus 2 Laps to a
Maximum of 15 Laps

A MAIN

To be run over 25 laps
Top 16 qualifiers plus 1st, 2nd 3rd & 4th from B Main
Top pointscorer from heats starts
from position 1, 2nd highest point
scorer from position 2 and so on.

DEFENDING CHAMPION: Previous year's champion allowed to defend title but must compete in heats. If fails to qualify by this means, may compete from ROF in own or substitute car. Such substitute car must be a car that has already competed in the heats. In this case will start from rear of A Main.

Trophies for 1st, 2nd & 3rd placegetters in A Main.

All A Main Drivers will receive a Medallion for qualification to the A Main. All participants in the State Title event will receive a participation medallion.

The Driver of the winning car will receive a Shirt in recognition of their success.

NOTE: Drivers must pass scrutineering, to be eligible for tow money.

NOTE: *Mandatory* use of Transponders & One Way communicators will be in force for this title. If you do not have your own transponder they may be hired from the QSCA Inc on race day. All competitors **MUST** have their own radio receiver.

SCRUTINEERING:

Will be held at the racetrack, in the designated area.

Scrutineering will be conducted between **1.00pm and 2.30pm on Saturday 31st May 2008.** NOTE: **ALL CARS** must be available for inspection between the above times. Cars will not be accepted after 2.30pm, unless prior arrangement has been made with the State Tech Rep QSCA Tony Cornelissen 0400288600 or State Secretary Terese Lange 0419 733 299. Late arrival will incur a penalty.

DRIVERS BRIEFING: **4.00pm** In the designated area in the pits.

LOG BOOK & LICENCES: Are to be handed to the scrutineer at scrutineering and obtained after the completion of the nights racing.

PRACTICE: NIL – All cars will be required to participate in Grand Parade for a transponder check.

RACING FROM: **5.00pm** unless otherwise notified

PROMOTION: ***Each driver is requested to supply a current photo of himself/herself and car for promotional purposes.***

GRID DRAWS: Nominations will close at the nominated date
Late nominations will be accepted up to 2 days before the title – with the payment of the late fee and be included in the draw
The draw will be deemed to be done at 6.00pm on the day nominated – 29th May 2008 (2 days prior to race meeting)
Any further late nominations, after the draw has been done will start R.O.F in all heats.

4. Nominations received by fax must have the original and cheque forwarded immediately, if not to hand within 7 days from close of nominations, will be required to pay the late nomination fee
5. Scratchings must be notified to State Secretary, (0419 733 299) prior to meeting. Failure to do so may incur a penalty.
