If applied for in the 2020, SSA Officials licence will expire 30/06/2023, 2021 will expire 30/06/2024 etc, but is only valid with a current Speedway Australia Licence, Working with childrens and accreditation.
- To carry out Official Duties on SSA Classes, Official's must have a current SSA National Licence, and be available on request.
- Please allow 21 days for return of Licence.
- Licence is FREE to all approved SSA Officials.
- Must have a current Speedway Australia Insurance prior to application being accepted.
- Please ensure that page 2 is signed by Applicant and State Secretary.
- All approved Officials details will be kept on a National Register.
