Agenda Item from Sunshine Coast -

To Speedway Sedans Queensland, - AGM agenda item,

The Sunshine Coast Speedway club recently asked SSQ for an explanation why title medallions were deleted from being presented during the 2019/20 season. A reply from SSQ was received and discussed & we now feel this should be an SSQ AGM agenda item.

We would like to see SSQ drivers asked by their clubs or at a title drivers briefing/meeting for their opinion on whether they still wish to receive title medallions or not.

If there is to be a change to rule 3.22 section 3 in the Speedway Sedans Queensland operations manual we think it should include input from the drivers.

To attend let alone successfully compete at any prestigious event such as a title is an achievement by anyone's standard and is a fond memory of most drivers who never get to win many trophies etc throughout their racing career. Or, has speedway become all about the prizemoney now?.

Discussions held – items raised.

- Can't be an agenda item for AGM agreed to be put on the general meeting agenda.
- Question has already been asked and answered by SSQ COM
- SSQ Operations manual does not require input from drivers/clubs.
- As per last COM Minutes it was noted that it is a very common occurrence to see the medallions still in drivers' logbooks for many meetings after, and often found in gear bags when gear is presented for the next title.
   Obviously for most drivers these are not "keepsakes" as is intended.
- Never any time given at tracks for the presentations
- To come into line with the SSA National Titles it was passed "That medallions be replaced with "small boards" for the 24 starters that take the track for the Qld title race numbered 2-24 with the other board marked as "polesitter", plus a small board for each heat winner."
- Further discussion indicated that perhaps boards for all competitors stating "competed" rather than top 20 and these could then be handed out when the car passed scrutineering. The heat winners and pole sitter boards would remain the same.

#### \* General Business

- SSA Turn 2 Funding announced with increased \$\$ to be able to assist more applicants
- SSA "Go Fund" has been implemented to assist drivers to compete at National Titles where long distances are involved 2000km has been noted unsure if this is one way. Up to \$500 is available to applicants.
- National Titles some may be in jeopardy of being held due to the COVID restrictions in place and that are looking like they will continue for some time.
- Titles and racing in Queensland will be back under way shortly- long discussions held regarding the requirements for the return to racing including COVID Industry Plans to be submitted, electronic sign on for gates. Extra planning and extra people will be required to undertake the requirements.
- Secretary to send to all COM information to hand regarding return to racing obligations and requirements as obtained in the process of Maryborough Club gearing up for Kart meetings to be held in July/August.
- SSQ has applied to become a registered provider to accept the "Fair Play" vouchers offered by the government for children to become involved in organised sport. Maryborough already has this in place.
- SSA has new website up and running

- Reminder of COM reports to Pam Franz ASAP.
- As no discounts are allowed to be given on actual car registrations SSQ could look at \$50 fuel vouchers to be given for each 20/21 car registration. This ensures that all SSQ competitors are getting a "thank you" rather than just the State Title competitors as not everyone attends titles. Vice President Donna has contacts in the fuel industry and is happy to contact them to see what can be obtained /organised in this regard.
