umbrella of our Speedway Australia recognised division of Super Street Sedans. Full adherence to the safety specifications will be required and the Super Street specification will be changed to accommodate their existing engine/tyre/fuel rules. This is for a minimum of 2 seasons and during this time they will be encouraged to comply with a SSA National division. As an introduction a suggested rate of Infringement Cards \$20 and Car Registrations \$30 plus must have Speedway Australia licence/insurance.

Discussions held – talk to Super Street drivers at Cairns title re the rules and where they envisage the direction the class is taking. At this stage they are running outside the rules – should have been sorted by 2017.
