- \* Carina Speedway Bundaberg Motorplex update by Allan Jennings.

### **General Business:**

- \* Letter from Sunshine Coast Club asking when a technical meeting will be called as discussed at the SSQ General Meeting. Discussion held there will need to be space there for cars to be brought in for "hands on" training, and it will be structured for Chief & Asst scrutineers from Clubs who are current and actively working. They then can take the knowledge back to their clubs and instruct trainees etc. REPLY A tentative date has been set and we are working on the venue for this technical education meeting.
- \* Complaints recently received from a number of race meetings at different tracks:-
- Query on the Social Media Policy in reference to a Junior Parent who films races "live" directly to Facebook, which is no problem but unfortunately the running commentary contains explicit language. Discussion held. No action at this time.
- The use of Golf carts and motorised scooters in the pits particularly as operated by Juniors running around the pits at speed and sometimes with no helmets. Outcome A letter to be written to all Clubs regarding this for them to take the appropriate action within their own clubs as required for duty of care as a matter of urgency. "Vehicles are to travel at a speed <u>not exceeding a brisk walking pace</u> within the pits/Speedway Complex".
- \* Nostalgia Sedans does the Window net SFI 27.1 apply to the Qld State class of Nostalgia Sedans at this time? Discussion held. Outcome was to leave it be for the remainder of this season and re-evaluate for next season. Will also look at Insurance to be Speedway Australia only not NDRA after this season.
- \* Scrutineering it was noted that a number of drivers had items written up in their log books at a previous meeting that were not done when presented for the next race meeting these items were then re-written in the book again. This matter has now been dealt with by Allan Jennings.
- \* Scrutineering at Maryborough 28.10.17 Allan Jennings and Doug Rigby attended to have a look at some Production Sedans they had not yet had a chance to see and look at some specific items in general overall on the division. Apparently this was assumed that they had taken over the scrutineering at the time. This was incorrect.
- A letter to be written to all Officials to advise that from time to time the SSQ may send Scrutineers or Officials to come and look at cars at scrutineering, or do spot admin checks on log books etc. This is not a reflection on the local scrutineers and officials, but an exercise to see cars and paperwork that they may not have previously had the chance see. Local Scrutineers and Officials need to continue to work as they normally would on any race day, with the SSQ officials happy to answer questions, or have a look at something, and offer advice.
- \* Engine Sealing Sheets recently some engine sealing sheets have just be re-done for an already sealed motor as the driver cannot locate the paperwork. Please be advised that the paperwork and records for this are kept on file and go back quite a number of years. At least some sort of effort needs to be made to locate the correct paperwork before just re issuing a new sheet.
- \* Engine Sealing the engine builder on the sheet should be stated as whoever removed the intact seals and worked on the engine IE; an professionally built engine if it has to have work done that involves breaking the specific seal (e.g.: driver taking the timing cover off) this driver now becomes the person listed as the engine builder when it is re-sealed.
- \* Query re what is deemed as inappropriate re sponsorships on cars. Not too many seasons ago certain cars were asked to remove stickers that were deemed offensive, but it seems lately that it has become an anything goes. Discussion held no action deemed necessary.
