General Business:

* Engine Sealer registration request - a reply was sent:-

In relation to your further enquiry in regards to becoming an Engine Sealer for engines that you build for your customers, we advise that at this time we are not prepared to grant you an engine sealers registration with Speedway Sedans Queensland. Your conduct towards our association over the past number of years, where you have continually degraded and berated both Speedway Sedans Queensland and Speedway Sedans Australia in public forums and on social media is not acceptable. Unfortunately this resulted in further posts on social media – Allan Jennings has a screenshot copy of the post and will forward to Executive for their information.

*Officials – Pam Franz reported that all Officials registrations will be cancelled as at 30.6.17. New forms and officials registrations will be required for all SSQ Officials – the training schedule has been extended to 3 years with the new Expiry for those who completed the last training session now August 2018.

* Daylight/Machinery inspections need to reflect the car being presented – i.e.: no engine or incomplete = no registration.

* SSA looking into the legal definition of "guardian" as used in our paperwork – ongoing.

- * SSA National Titles:-
- -2017/18 increased tow money
- C main if not used will have \$ distributed between all competitors.
- 3 gate passes NOT REQUIRED as per letter submitted from South Burnett Club
- Change the format of national Titles input requested (not 5 heats)

* SSA – Radio Channels – Government audit of the radio channels being used for speedway – SSA owns the radio channel licence and all tracks then use them – government wants every track to buy their own licence. For now SSA is to be aware of every race meeting where the channels are being used.

* AGM Agenda items – Items from Lockyer Valley read to meeting – general discussion held.

* President Allan Jennings reminded everyone of the confidentiality of the items/persons discussed at our COM meetings. People need to be very mindful of this – general discussion held.

* National 4's Qld Title – sponsorship offer is no longer on the table – it was meant to be used to try and increase car count by more tow money etc. not just to give a track a "free" title.

* Please be mindful of member information that is given out to people outside the SSA & SSQ chain of command. If any Club or member of COM is asked to give out a member's mobile/home phone number please do not do so. We can take their number and forward it onto the person concerned for their attention.

* Qld Titles – EOI to work at Qld Titles and at Qld blue ribbon events to be included on SSQ paperwork – Pam Franz to attend.

* Next COM meeting now to be 26th July – closer to AGM and Vice President away until 24.7.17
