#### 4) Minutes of Previous Meetings

a) Speedway Sedans Qld (QSCA Inc.) State Meeting Minutes – 12 August 2018.

Business Arising from Speedway Sedans Qld State Meeting Minutes – 12 August 2018

Sunshine Coast – National 4's front wheel drive to rear wheel drive conversion trial car (copy attached).

Response –

- SSQ was aware only of a stated conversion prototype only approved as a conversion from front wheel to rear wheel drive only to see if the process could be done, not as a trial car.
- In reality only two states have National 4's Qld and NSW.
- It was advised that a second trial car build had been given permission from SSA Technical August 2017.
- It is known process that trial cars cannot compete in National or Queensland titles for the 12-month trial period.
- The trial car should present with its own specific paperwork and current specs for the division as a whole should not be changed as technically the car may not go ahead after the trial period.
- At this point in time there are no specifications available to our officials to daylight or to be able scrutineer when the trial car gets to the racetrack.
- David Weir stated that as CTAC Chairman he is not responsible for the disbursement of information to all only to the relevant CTAC members.

**Outcome**- Allan Jennings and Doug Rigby will present and discuss further at SSA technical as to what process needs to be followed going forward regarding these cars. Also requesting State to be involved in the process as at present the lack of information is causing conflict.

Raised by Allan Jennings - Charlton - regarding comment in COM Minutes 10.4.19 as follows:

- Toowoomba – Whilst the advertising and exposure is great for Sedans perhaps a little "over the top" with the title of "T Bar Nationals" to the extent that many people thought the event WAS the National Title for this division. **Response-**

When read in its entirety the comment was not meant to be derogatory to Charlton promotion of their events. Unfortunately, the comment was not interpreted this way and the SSQ apologises for any ill feeling that this may have caused as it was certainly not the intention. Charlton's approach and delivery of the promotion of its events is to the highest standard and the effort and time that goes into this is certainly noted.

The comment was made in response to a number of queries received by members of the COM from Facebook information. Some people were confused why there were two National Titles for Modified Sedans one in Toowoomba and then another at Kingaroy not long after. The queries were addressed and the people given the relevant and correct information. It appears that the wording TBar Nationals was misinterpreted by people, unfortunately people do not read the full story on lots of Facebook information and in this case they had the wrong idea by just picking the word "national" from the promotions.

**Response** – CTAC expressions of interest were emailed to all clubs as per the COM directions. Gympie Club was proven to have received the email and did indeed table the CTAC EOI information at their monthly Club meeting – it is the club's responsibility to disseminate the information to their club members.

**Outcome**: Going forward SSQ will change the system to also include sitting CTAC members in the EOI mail out.
